File is to be a character-delimited file. The character used as the delimiter is the pipe '|'.

If optional fields are unavailable, denote the field with the value NULL

Performances of the same song for the same Licensee are to be aggregated to calculate the total number of plays for the performance period reported.

For name fields, if the individual is known by a single name (i.e. Madonna) it is suitable to provide a single name otherwise provide name as First Name Last Name of individual.

If multiple names are to be provided separate names with a comma (i.e. Madonna, John Smith), same rule applies for publisher names (i.e. Publisher Name 1, Publisher Name 2).
